- ✓ Attach a typed essay response. (double spaced, please)
- ✓ Attach an official ACT/PSAT/SAT high school transcript with the student's GPA for Grades 9-11 (and Grade 12, if available). This should be obtained through your high school guidance office.
- ✓ Attach a signed Certification and Release Authorization Form. This form is located on the back page of this application packet and must be signed by both the student and his/her parent.
